Coping with MiFID II's Unintended Consequences

Nearly two years after MiFID II's wide-ranging new rules took effect, European market participants are still coming to grips with the unintended consequences, including an array of new venues complicating the trading landscape. At the same time, alternative venues are pursuing further fragmentation by launching rivals to listing-exchange closing auctions, and European policymakers are moving forward with plans for a consolidated tape.
