

## **CONSENT - OPENING OF ACCOUNTS AND LGPD**

Pursuant to Law No. 13,709, of August 14, 2018, the Client hereby expresses his free, informed and unequivocal consent for Passfolio and RB Investimentos to use their Personal Data (“Data”), for the following purposes:

- (i) Registration for the purpose of opening the Client's account with Passfolio (<https://www.passfolio.us>), in accordance with the terms and conditions of the Contract entered into by the Client;
- (ii) Pre-registration for the purpose of opening the Client's account at RB Investimentos (<http://www.rbinvestimentos.com.br/>), to comply with regulatory obligations, in accordance with the terms and conditions of the Contract entered into by the Client; and
- (iii) Data sharing between Passfolio and Rb Investimentos will be carried out exclusively for the fulfillment of the contract and legal and regulatory requirements, such as the verification of the customer's profile (KYC) and suitability of the products (suitability).

The client also expresses knowledge about the use of his Data for the proper provision of the Services covered by this Agreement and the fulfillment of legal and regulatory obligations, whether Brazilian or foreign.

If more information or documents from the Client are needed to complement the registration and / or meet legal or regulatory requirements, these will be requested through the Passfolio Platform.

Passfolio and / or RB Investimentos may share the Data in part or in whole with governmental and administrative entities, whenever they receive an order that arises from a legal obligation and / or is necessary to fulfill this contract and / or the interests of the Client, of Passfolio and / or RB Investimentos in eventual judicial, arbitration or administrative demands.

The processing (or treatment) of the Data hereby agreed will only occur for the reasons previously communicated, in accordance with the purposes above. If there is a need to use the Data for other reasons, the Customer will be duly notified and additional data protection measures will be implemented according to the requirements of the law.

The Client may request, at any time, under the terms of the law, that Passfolio and / or RB Investimento inform which Data were collected and which concern them, as well as their rectification or elimination, as the case may be. For this purpose, you can make such communications by e-mail [[lgpd@rbcapital.com](mailto:lgpd@rbcapital.com)] (if for RB Investimentos) or [[suporte@passfolio.us](mailto:suporte@passfolio.us)] (if for Passfolio).

The rectification or deletion of the Data is subject to its dispensability for compliance with legal and regulatory obligations.

The Data will be stored for the reasonable time necessary to fulfill the purposes for which it was collected, except in cases where the Data is necessary for the fulfillment of legal, regulatory or contractual obligations.

Passfolio and RB Investimentos recognize and take seriously the responsibility to protect the Data and use a variety of security technologies and organizational procedures to help protect the Data.

In any case of violation of the Data, we will take the appropriate measures under the law and, if this fact is likely to imply a high risk to the rights and freedoms of the owner, this fact will be communicated to you, under the terms and conditions provided for by law.

The privacy policy may be updated by Passfolio and / or RB Investimentos periodically, in accordance with what is necessary to reflect its privacy and data protection practices, as well as any regulatory updates, with adaptations being duly informed to the Client when they are made. occurrence.

We reinforce that the Client is entirely responsible for the confidentiality of his information and Data, being forbidden to share his login, passwords or any type of access or authentication credential with Passfolio and / or RB Investimentos.
