- your conduct in publishing the matters complained of knowing:

 - knowing or foreseeing that the defamation consequently harmful imputations could spread throughout the world via social media.

ACTION REQUIRED

Our client seeks the following from you within 7 days of the date of this Concerns Notice:

- immediately take down + remove your defamatory posts;
- retract your comments by completing the apology in the form **attached** and returning by email or letter;
- undertake not to repeat the defamatory imputations above or any similar aspersions about our client in the future; and
- pay our client compensation and costs, to be agreed or assessed.

RESERVATION OF RIGHTS

We reserve all of our client's rights, including the right to commence proceedings against you, without further notice, should you not agree to these demands.

In particular, further aggravation to our client's harm and therefore claimable damages will occur should you:

- fail or refuse to apologise to our client; or
- seek to publicise her complaint in any way (thereby repeating the defamation).
