I affirm:

1. The document dated August 20, 2020 and signed in the margin by me and by the person before whom this affidavit is sworn is, I believe, the last will of Ruth Regatta, late of Coogee, yachtsman, the deceased, and I am not aware of the existence of any other document purporting to embody the testamentary intentions of the deceased.
2. My means of identifying the will are: I am the deceased's friend, and am familiar with her handwriting and signature as I have seen it on many other documents (such as her marriage certificate where I was present as a witness at the scene).
3. The attesting witnesses to the will are Will.i.am Witness and Some Random Witness.
4. The deceased died on August 26, 2020 aged 85 years and I believe that the deceased is Ruth Regatta referred to in the certificate of registration of death which is annexed and marked Annexure "A".
5. The deceased did not marry after the will was made.
6. The deceased left assets within New South Wales.
7. I am the executor named in the will and I am over 18 years of age.
8. If I am granted probate of the will of the deceased:
 - (a) I will administer the estate according to law; and
 - (b) I will:
 - (i) verify and file; or
 - (ii) verify, file and pass,my accounts relating to the estate of the deceased within 12 months from the date of grant if so required by the Court.
