This petition concerns earth-filling work carried out on the river front areas of two rivers, namely, Galgibag and Maxem. The present controversy concerns compliance with the order passed by this Court on 02.05.2019. By this order, this Court recorded and accepted the statement of learned Advocate General that the recommendations made in the report of Dr. Prabhakar Shirodkar concerning earth-filling, would be complied with, on or before 31.05.2019. The recommendation required the State Government to remove the earth-filling in the water front of river Galgibag, between Pillar 10 to Pillar 11. The present grievance of the PIL Petitioner is that there is no compliance with this statement.

2. Learned Advocate General submits that his instructions are that, there has been a compliance with the statement made before this Court on 02.05.2019, and that, he would like to place the requisite facts alongwith the photographs on record. Additional affidavits filed by the Petitioner, both in the Contempt Petition and in the original PIL Writ Petition, in this behalf, are taken on record. The State shall file its affidavit, as proposed by learned Advocate General, within a week from today.

3. Let these petitions come up for admission on 5<sup>th</sup> July, 2019. As far as possible, the parties should be ready to go on with the main PIL Writ Petition.
