POSTGRADUATE STUDIES AT THE WORLD MARITIME UNIVERSITY (WMU) TERMS AND CONDITIONS OF THE SCHOLARSHIP

1. Study Programme

- 1.1 This Scholarship is granted for the approved period of studies in accordance with the acceptance from WMU.
- 1.2 The Scholarship is intended for study programs approved by TETA. Any change to a different specialisation within the approved programme is allowed in the event that such request is motivated and accepted by The University in writing. Subject to the University acceptance, a written approval or decline must thereafter be provided by TETA to effect such a change. This approval will be at TETA discretion and will not be automatic. Any other action may result in TETA withdrawing the Scholarship.
- 1.3 Learners are not allowed to change institutions at any point during a funded programme.

2. Funding

- 2.1 The funding of the scholarship will be paid by TETA directly to the University.
- 2.2 The funding covers the following while in Malmö: tuition, field studies, insurance, accommodation, a monthly living allowance and an air ticket after graduation back to South Africa.
- 2.3 Once all approvals and travel documents are in place, TETA will make the travel arrangements for the learner to fly from South Africa to Sweden. Any other costs will remain the responsibility of the learner, to be funded through the monthly allowance provided by TETA for the duration of their stay in Malmö.
- 2.4 It is the responsibility of the learner to ensure that any items not mentioned in the scope of the funding are covered by the learner. TETA will not fund any related expenses or purchasing of additional material or equipment as identified by the learner (e.g. laptop, stationery, provisions for deposit at residence, related transport allowances while in the country of study, etc.).

- 2.5 It remains the learner's responsibility to ensure that he / she has a valid passport and required residence permit for the duration of the studies. The cost related to obtaining such documents is the learner's responsivity.
- 2.6 It remains the responsibility of the learner to pay any costs related to exceeding luggage at the time of travel from and to South Africa. TETA will not be responsible for any related costs for extra luggage.
- 3. Upon graduation, the learner will undertake all endeavours to work within the transport sector in the Republic of South Africa for a minimum of 3 (three) years.

4. Research

4.1 The funding opportunity requires the learner to undertake research based activities in the SA environment relevant to South Africa's maritime context.

5. Life in Malmö

- 5.1 It remains the responsibility of the learner to ensure he / she is well informed of the requirements while living in Malmö for the duration of the study programme.
- 5.2 The learner can access more information through www.wmu.se, or contact the WMU Admissions Office, msc@wmu.se for further information regarding the programme as well as living conditions while in Malmö.
- 6. The learner may be obliged to pay back the entire value of the scholarship, if he/she does not comply with the terms and conditions of the Scholarship.
- 7. If the learner does not fulfil the requirements of the programme in terms of the University's Rules, Regulations, Policies Procedures, and Statutes as amended from time to time, his/her scholarship can be withdrawn.
- 8. Should the learner be found to be involved in any acts that are contrary to The University's Rules and guidelines for student conduct and is duly found guilty of such, TETA's scholarship will be automatically revoked and learner may be obliged to pay back the entire value of the scholarship.
- 9. Should the learner, for any reason whatsoever, wish to resign from the programme before obtaining the degree, he/she must inform TETA in writing, giving reasons for his/her resignation from the program. All costs related to the funding of the programme until the time of resignation from the programme will be refunded by the learner to TETA.
