**Submittal must include all of the following in concise detail:**

- A \$500.00** check payable to the BVSA Environmental Control Committee. This includes a completion deposit of \$200.00, which is refunded to the property owner of record upon completion of approved additions and or alterations without violations. Refund of the \$200.00 completion deposit is contingent on receiving a job card construction permit signed off by the Kern County Building Department. Also included is a non-refundable inspection fee of \$100.00 and a non refundable filing fee of \$200.00. **Note: If the project is not completed within the required one year time frame an additional \$100.00 fee is required with the extension.**
- Plot Plan:** Two sets, to scale, showing property boundaries, setback distances, and location of: structures, trees (identify which to be removed/trimmed) and easements. Any addition or alteration from previously approved plans must be clearly defined. This would include septic tanks, propane tanks and screening, off-street parking and driveways.  
**Note: New driveways require a BVCS D Encroachment Permit Application.**
- Floor Plans:** Two sets are required. Should be 1/4" = 1' scale, showing total square footage (show square footage of each floor if building is multi-storied).
- Elevations:** Two sets of front, rear and side drawings to scale, indicating exterior materials and colors of siding, trim, roofing and window frames. Show location of all exterior lights including security lights and indicate type of shielding. Show maximum total height of building.
- Specification form completed, initialed and signed by the property owner.**
- Colors:** Sample of all colors must be specified on checklist.

*I hereby certify that I have read the Bear Valley Springs C&R's and the Environmental Control Committee Rules, and to the best of my knowledge, this submittal is in compliance therewith.  
 Prior to submitting plans for approval, I agree to stake out the perimeter of the building and to distinctly mark all trees which are to be cut or trimmed prior to submitting plans. I agree to request inspection of the foundation trenches by the ECC Field Representative before pouring concrete. I agree to complete construction within twelve (12) months from the start date (delivery of materials or trenching).*
