Submittal must include all of the following in concise detail:

- CSD Encroachment Permit Application & paid Water Service Application** (*One copy of each is required*).
- Grading Plan** if required by Kern County (*two sets*)
- A \$5,000.00 check payable to the B.V.S.A. Environmental Control Committee.** This check includes a non-refundable portion of the deposit in the amount of **\$600.00**, a non-refundable inspection fee of **\$100.00**, a non-refundable architectural design review fee of **\$400.00** and a non-refundable filing fee of **\$400.00**. If an architect is requested for consultation on a project, a fee of **\$250.00** will be charged. The remainder of the deposit may be used to pay for any damages to or cleaning of the common area, roads and or other private property and/or as payment of fines for violations of the ECC rules after due process is provided. Any unused portion of the deposit will be refunded upon completion of the home and upon receiving a "job card construction permit signed off by the Kern County Building Department." A non-refundable fee of **\$100.00** of the deposit will be kept if your building plans are cancelled. ***If the project is not completed within the required one year time frame, a request for an extension must be submitted. There is an additional \$100.00 fee for an extension request.***
- Plot Plan:** Two sets **to scale** showing property boundaries, setback distances, location of structures, drainage, trees (identify which to be removed/trimmed), septic tank, screen for a propane tank, roads and driveways.
- Floor Plans:** Two sets to 1/4" – 1" scale, showing total square footage of living area (show square footage of each floor if building is multi-storied). Include locations and dimensions of garage, carport, decks, stairways, balconies, fireplaces and exterior air conditioning units.
- Elevations:** Two sets of front, rear and side drawings to scale, indicating exterior materials. Show location of all exterior lights including security lights and indicate type of shielding. Show maximum height of building. Include exterior structures as indicated in #5 above.
- Specification form completed, initialed and signed by the property owner.**
- Colors: Sample of all colors specified on checklist.**

I hereby certify that I have read the Bear Valley Springs C&R's and the Environmental Control Committee Rules and to the best of my knowledge, this submittal is in compliance therewith. Prior to submitting plans for approval, I agree to stake out the perimeter of buildings and pathway of driveway to determine the location and scope of any and all easements which may cross over my property, and to distinctly mark all trees which are to be cut, prior to submitting plans for approval to the ECC. I agree to request inspection of the foundation trenches by the ECC Field Representative before pouring concrete. I agree to complete the construction of the foundation and all exterior surfaces within six (6) months after commencing construction (Per C&Rs Sec. 7. Land Use; sub paragraph C-3.
