IN 2015, THE ORGANIZATION PARTNERED WITH LOOSE LUGGAGE MEDIA, INC, REQUIRED READING, LLC, AND JOURNEYMAN PICTURES TO PRODUCE AND DISTRIBUTE I AM SUN MU, THE CRITICALLY ACCLAIMED DOCUMENTARY ABOUT A FORMER NORTH KOREAN PROPAGANDA ARTIST WHO ESCAPED TO THE SOUTH AND NOW USES HIS TALENT TO CREATE SATIRICAL POLITICAL POP ART. ADDITIONALLY, THE ORGANIZATION BEGAN WORK ON A DOCUMENTARY, SET TO RELEASE IN 2016, THAT HIGHLIGHTS CHANGES HAPPENING INSIDE NORTH KOREA, AND THE MILLENNIAL GENERATION WHO ARE LEADING BOTTOM-UP MARKETIZATION AND PUSHING SOCIAL PROGRESS, ALL DESPITE LIVING UNDER ONE OF THE WORLD'S MOST REPRESSIVE REGIMES. THE ORGANIZATION ALSO CREATED 109 SHORT FILMS AND VIDEOS TO SHARE ONLINE, IN PRESENTATIONS, AND AT EVENTS AROUND THE WORLD.

2) ENGAGING WITH INTERNATIONAL JOURNALISTS AND POLICYMAKERS: THE ORGANIZATION ENGAGES WITH INTERNATIONAL JOURNALISTS, FILMMAKERS, DIPLOMATS AND OTHER POLICYMAKERS TO INFLUENCE THE WAY THE MEDIA REPORTS ON NORTH KOREA AS WELL AS THE WAY THAT GOVERNMENTS AND POLICYMAKERS THINK ABOUT THE ISSUE. IN 2015, THE ORGANIZATION WAS CITED 120 TIMES IN THE MEDIA, HELPING TO INFLUENCE AND SHAPE PERCEPTIONS ON NORTH KOREA AND DRAW FURTHER ATTENTION TO THE NORTH KOREAN PEOPLE AND THE IMPORTANT CHANGES THEY ARE DRIVING INSIDE THE COUNTRY.

3) DIRECT GRASSROOTS ENGAGEMENT: THROUGH GLOBAL ONLINE CAMPAIGNS AND TOURS ACROSS NORTH AMERICA, THE ORGANIZATION SHARES THE STORIES OF THE NORTH KOREAN PEOPLE AND PROMOTES A BROADER PERSPECTIVE ON THE ISSUE. IN 2015, THE ORGANIZATION REACHED NEARLY 40,000 PEOPLE AT NEARLY 700 VENUES ACROSS NORTH AMERICA. ALSO IN 2015, OVER 250 RESCUE TEAMS (CHAPTERS) AROUND THE WORLD ACTIVELY WORKED TO BUILD SUPPORT FOR THE NORTH KOREAN PEOPLE ON A LOCAL LEVEL. THE ORGANIZATION'S WEBSITE SAW OVER 400,000 UNIQUE VISITORS IN 2015.
