SO, WE BUILT THE LINK COMMUNITY! OUR LINK COMMUNITY GATHERINGS GIVE RESETTLED REFUGEES A PLACE TO MEET OTHER NORTH KOREANS WHO UNDERSTAND THE UNIQUE CHALLENGES THEY FACE. THROUGH WORKSHOPS, COMMUNITY EVENTS, AND ONE ON-ONE SUPPORT, THE LINK COMMUNITY IS EQUIPPING AND EMPOWERING NORTH KOREANS TO THRIVE IN THEIR NEW LIVES. IN 2019, THE ORGANIZATION SUPPORTED AND EMPOWERED 150 NORTH KOREANS. THE GOAL: EMPOWER YOUNG NORTH KOREANS TO SHARE THEIR STORIES WITH THE WORLD. IN 3 MONTHS OF THE FELLOWSHIP, 4 NORTH KOREAN ADVOCACY FELLOWS SHARED THEIR STORIES IN ENGLISH WITH OVER 2,780 PEOPLE AT 21 EVENTS ACROSS THE UNITED STATES. OF THOSE WHO ATTENDED AND RESPONDED TO A SURVEY, 96% WERE INSPIRED TO SHARE MORE ABOUT THE NORTH KOREAN PEOPLE, 90% WERE EMPOWERED TO CONTRIBUTE TO THE MOVEMENT, AND 65% FELT MORE HOPEFUL FOR THE FUTURE OF THE KOREAN PENINSULA.
