

FACTS**WHAT DOES BROKER SOLUTIONS INC. DBA KIND LENDING DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social Security number and credit history ■ employment information and income ■ mortgage rates and payments and transaction history <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons BROKER SOLUTIONS INC. DBA KIND LENDING chooses to share; and whether you can limit this sharing.

What we do

How does BROKER SOLUTIONS INC. DBA KIND LENDING protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does BROKER SOLUTIONS INC. DBA KIND LENDING collect my personal information?

We collect your personal information, for example, when you

- apply for a loan or give us your employment history
- give us your income information or provide your mortgage information
- show your government-issued ID

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include financial companies such as **EMPOWER ESCROW, INC. AND REHOMECONNECT.COM.***

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- ***BROKER SOLUTIONS INC. DBA KIND LENDING** does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- ***BROKER SOLUTIONS INC. DBA KIND LENDING** doesn't jointly market.*

Other important information

CALIFORNIA: IN ACCORDANCE WITH CALIFORNIA LAW, WE WILL NOT SHARE INFORMATION WE COLLECT ABOUT YOU WITH COMPANIES OUTSIDE OF BROKER SOLUTIONS, INC. DBA KIND LENDING UNLESS THE LAW ALLOWS. FOR EXAMPLE, WE MAY SHARE INFORMATION WITH YOUR CONSENT, TO SERVICE YOUR ACCOUNTS. WE WILL LIMIT SHARING AMONG OUR COMPANIES TO THE EXTENT REQUIRED BY CALIFORNIA LAW.

VERMONT: EXCEPT AS PERMITTED BY LAW, WE WILL NOT SHARE INFORMATION WE COLLECT ABOUT YOU WITH NONAFFILIATES OR AFFILIATES.
