The Craft Council Gallery seeks submissions for the second annual Clay Studio show. This exhibition extends the Gallery mission by showcasing current relevant and diverse practices in fine and contemporary craft in the province focusing on the field of ceramics. This exhibition provides a spotlight on the breadth of work currently being made that utilizes clay as a featured material. It is our hope that Light! exhibition will connect emergent and established makers' users of the Clay Studio, and will include some of the best utilitarian, sculptural, traditional and/or experimental work being created today.

ABOUT THE THEME

Light is defined as the brightness that comes from the sun, fire, etc. and from electrical devices, and that allows things to be seen. It also means something that does not weigh a lot. With so many different meanings to one word we want to see your interpretation. Think of vibrant colours, unusual shapes, day-to-day objects that carry light or are light for carrying.

Your pieces do not have to be in until September 25th, 2020 but we do need to know with how many pieces are you applying and what are they in advance! If they needed to be changed because they broke in the kiln or the glaze ran, no problem! Just send us an email in advance explaining the reason and a new form with the new piece!

Guidelines

- Open to the Craft Council Clay Studio users, instructors and studio hosts.
- Work must address the theme in either a formal, visual and/or conceptual manner and be made primarily out of clay.
- The artist is responsible for shipping to and from the Gallery. The Gallery and the Clay Studio is responsible for insurance during the exhibition.
- All work must be for sale.
- Work which differs from the submitted image will be disqualified.
- Artists may submit images for up to three entries, and a maximum of two images for each entry.
- Works will be accepted on the basis of excellence in technique, use of materials and design. The jury will choose pieces that will build a cohesive exhibition of one-of-a-kind works. Works should have been created in the past two years.
- Artists may submit up to three (3) works clearly identified, one of which may be a set and a maximum of two clear, true colours, images for each entry. **All entries must be ready to install** and should come with specific installation, hanging and/or other necessary instructions in writing.

Artist Bio and Statement about the submitted piece(s) (roughly 150-250 words each)

2 Images of each submitted piece with the following specifications:

- The image must be a true copy of the original art work
- File format must be JPEG (.jpg) or TIFF (.tiff) only
- Please ensure the image you upload is cropped so that only the work image is visible. Use a photo or image editing program to remove unwanted parts, including but not limited to, frames and/or borders.
- Minimum image size is 6" x 9" at 300dpi, or 1800px x 2700px.
Images of 11" x 17" at 300dpi, or 3456px x 5184px and larger would be preferred.

Work is properly packed in a reusable packaging and is insured for transit to and from the gallery.

The gallery is only responsible for insurance while the work is within the gallery premises. If works are not sold, artists will be notified via the email provided by the artist and works must be picked up immediately following the end of the exhibition. After 30 days of such notification the works will be removed from inventory and the craftsperson has been notified, the work becomes the responsibility of the craftsperson. The Gallery will not be held responsible for damage or theft after this point if after 6 months work is not collected or arrangements made for its pick up, the Gallery will assume ownership of this abandoned work and use it for their own fundraising efforts. Artwork purchased by customers at the Gallery will be packed and shipped by Craft Council staff.
