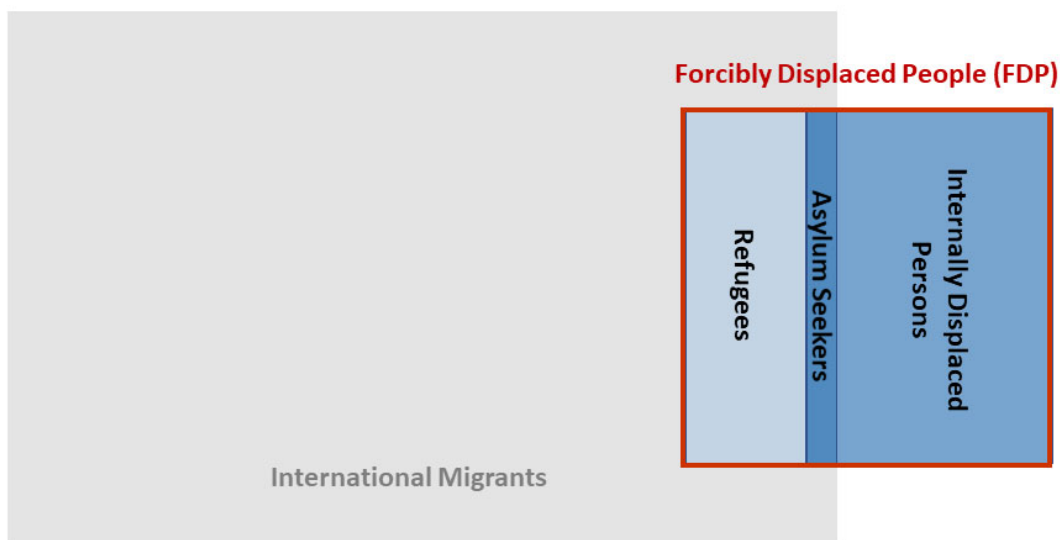


Terminology of Forced Displacement



Migrants or talk about immigration is a big focus of news and political discussions today, and there is often a lot of confusion and misunderstanding about how different terms are used. At IAFR we serve *forcibly displaced people* – a broad category which describes people who have fled their homes involuntarily. Forcibly displaced people are often referred to as *refugees*, *asylum seekers*, and *internally displaced people (IDP)*. While these terms are sometimes used interchangeably, they are distinct ideas which are important for making sense of the global movements of forcibly displaced people.

The diagram below aims to depict how the proportions of these groups relate to each other.



INTERNATIONAL MIGRANTS

International Migrants are people living outside of the country of their birth. There are approximately 272 million migrants in our world today.ⁱ

FORCIBLY DISPLACED PEOPLE

Forcibly Displaced People (FDPs) are people uprooted from their homes involuntarily, often in response to war, violence or other humanitarian disaster. As of the end of 2020, there were 82.45 million forcibly displaced people in our world. According to the UNHCR, more than 1% of the world's population is displaced.ⁱⁱ

INTERNALLY DISPLACED PEOPLE

Internally Displaced People (IDPs) are a sub-category of forcibly displaced people. IDPs have been forced to flee their homes, but not their country. There are approximately 48 million Internally Displaced

People in our world, making them the largest group of forcibly displaced people (about 58% of FDPs). They remain under the authority of their own government, even though it might be the direct cause of their displacement.ⁱⁱⁱ IDPs are among the most vulnerable uprooted people as there is no international treaty to protect or assist them.

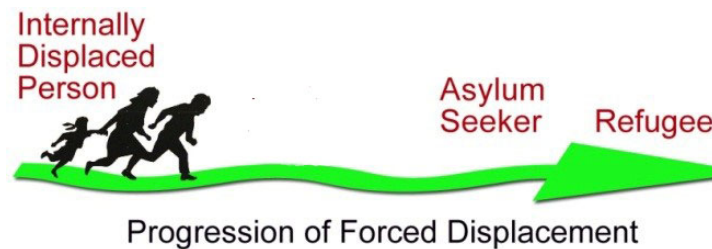
REFUGEES

Refugees are another sub-category of forcibly displaced people. Refugees have had to cross an international border in search of safety, seeking refuge outside of their home country.^{iv} There are 26.4 million refugees in our world, accounting for about 32% of forcibly displaced people.^v

ASYLUM SEEKERS

An *Asylum Seeker* is someone asking for protection in a foreign country but whose claim to need protection has not yet been definitively evaluated. If their case is approved, they will receive refugee status. There are about 4.1 million people seeking asylum in our world,^{vi} making up 5% of the world's forcibly displaced people. If their case is rejected, they may receive another form of temporary protection or be ordered to leave or be deported to their country of origin.

Some who are forced to flee their homes will begin as internally displaced people, fleeing within their own country in search of safety after disaster strikes. If they fail to find refuge inside their home country, they may cross international borders in search of help. At this point they could be described as asylum seekers. After they have had a chance to have their case heard by a third party (like a foreign government or the UNHCR) and their claim for need or protection is validated, they become a refugee.

A refugee has a well-founded fear of persecution for reasons of race, religion, nationality, political opinion or membership in a particular social group. Most likely, they cannot return home or are afraid to do so.
