- Will notify Community Board #2 & 41<sup>st</sup> Precinct in writing should security company terminate contract.
- Owner will not have ATM machine blocking main entrance
- No loitering in front of their establishment
- Owner will sign agreement to above stipulations together with Community Board 2.
