The CMF Equity, Diversity and Inclusivity Fund (EDIF) provides financial grants to support people from a diverse range of backgrounds and assist in their inclusion in the CMF community and participation in CMF activities. The EDIF offers to cover registration fees for conference and workshop attendance – at present, we are unfortunately unable to offer funds for travel, accommodation and other expenses.

Who can apply?

The EDIF grants are open to all. This includes, but is not limited to, members of the Compassionate Mind Foundation, as well as clinicians, researchers and practitioners interested in the science of compassion, research and practice in compassion focused therapy, and generally cultivating the compassionate mind in others and oneself.

Eligibility

Applications for EDIF grants must focus on diversity and inclusion, including (but not limited to) diversity across gender, ethnicity, culture, country of residence and financial status.

Applications relating to a range of participant groups will be considered, including different age groups, career stages, geographical regions and sectors.

The principle of the EDIF grants is to allow those who might otherwise not be able to attend CMF activities to become included and involved.

Assessment Criteria

Applicants should show that the requested funding will make a significant difference to their ability to participate in, develop from and contribute to the CMF community.
