"**Relevant Conduct**" is defined as any conduct or behavior, committed or threatened, in the past or currently, which includes any one or more of the following:

1. Violence of any sort or degree;
2. Any Public Order offence as defined in the laws of Bermuda criminal legislation;
3. Any Misuse of Drugs offence;
4. Gang activity;
5. Gang membership;
6. Gang associations.

For the avoidance of doubt, Relevant Conduct includes:

- a. Any act at any school, public or private, in or outside of Bermuda;
- b. Any act whether it is in connection with football or not; and
- c. Any act whether it is at a football ground or football match or not.

I HEREBY CONSENT TO BE REGISTERED AS A PLAYER FOR THE ABOVE NAMED CLUB IN ACCORDANCE WITH THE ASSOCIATION'S RULES GOVERNING THE QUALIFICATION OF PLAYERS (DOMESTIC COMPETITIONS) AS WELL AS ANY OTHER POLICIES OR REGULATIONS PERTAINING TO THE REGISTRATION OF PLAYERS AS DECIDED BY THE EXECUTIVE COUNCIL FROM TIME TO TIME.
