DELWP is undertaking analysis using modelling of fuel accumulation to identify areas suitable for planned burning in the next three years. Fire agencies are also working with communities to support their planning around more localised understanding of risk and township protection actions. The government response to IGEM commits DELWP, in collaboration with EMV and other land and fire managers, to lead the development of a whole of sector strategy to guide land and fire management in the context of a changing climate, growing population and changing demographics. In addition to public land, the whole of sector strategy will consider how to effectively support road managers and local governments to mitigate bushfire risks on roadsides and in high bushfire risk local government areas. A strategic firebreak initiative has commenced to reduce risk along key access roads and township interface areas.
