Sterilised: A dog or cat that has had a surgical procedure to remove all or part of the reproductive organs to prevent it breeding.

Working Dog: Dogs kept for working stock. Dog must be kept solely for the purpose of working cattle, sheep, alpacas or goats.

**VCA:** Victorian Canine Association operating as Dogs Victoria.

Approved Person: A Statutory Declaration can be witnessed by a Justice of the Peace or Police Officer above the rank of Sargeant: Oaths and Affirmations Act 2018.
