#### **Hard Words**

**Domestic wastewater system:** Most rural properties are not serviced by reticulated sewerage infrastructure. Domestic wastewater systems must manage effluent onsite (e.g. a septic system).

**Bushfire Attack Level (BAL):** The BAL is a measure of the severity of a building's potential exposure to ember attack, radiant heat and direct flame contact. It is expressed in increments of radiant heat exposure and provides the basis for establishing the requirements for construction to improve protection of building elements.

**Geotech Assessment:** Bushfires have a significant impact on the landscape due to the loss of vegetation by the fire and clearing of vegetation during clean-up. The assessment determines how to manage erosion and landslip risk through siting and design of dwellings, associated landscaping and erosion management controls.
