This form is to help you make an **objection** to a planning permit application in line with the Planning and Environment Act 1987, and which can be readily understood by East Gippsland Shire Council. You do not have to use this form to make an **objection**. Do not use this form to make a submission about a planning scheme change.
2. Make sure you clearly understand what is put forward before you make an **objection**. You should look at the application at one of Council's offices, or via the Advertised Planning Permit Application Section of this website ([advertised Planning Permit Application \(eastgippsland.vic.gov.au\)](http://advertised.Planning.Permits.Application(eastgippsland.vic.gov.au).)).
3. To make an **objection** you should complete the details on this form and submit it with Council.
4. An **objection** must explain:
 - Why you **object** to the application, and
 - How you would be affected if a permit is granted.
5. Council may reject an **objection** which it considers has been made to secure **commercial** benefit for the **objector**.
6. Any person may inspect an **objection** during the Council's office hours.
7. If your **objection** is about an effect on property that is not your address shown on this form, give details of that property and your interest in it.
8. Council must consider every objection lodged before a determination is made. Council will not determine the matter before the latest date listed on Form 2 (or Form 3 for an amended permit) as distributed to neighbours, displayed on the site, or published in a newspaper circulating in the area.
9. If you object before the determination is made, Council will tell you its decision via a Notice of Decision to Grant a Planning Permit.
10. The Notice of Decision to Grant a Planning Permit will explain your rights to review the determination at VCAT, the timeframe for review application to be made, and how to contact VCAT.
11. If Council refused the application and the permit applicant seeks review of such determination, an objector will be contacted through that process and can seek to join as respondent

Hard Words

Object: Say something to express one's disapproval of or disagreement with something.

Objector: The person/s disagreeing or disapproving.

Objection: An expression or feeling of disapproval or opposition; a reason for disagreeing.

Commercial: Concerned with or engaged in making or intending to make a profit.
