Terms and Conditions
AUTO SURVEY 2019/2

- 1. Information on how to enter and Prizes form part of these terms and conditions. Submission of an entry is deemed acceptance of these terms and conditions.
- 2. To enter, entrants must, during the promotional period fully complete and submit the survey. On completion and submission, entrants will be automatically entered into the prize draw.
- 3. Subject to clause 4, entry is only open to Australian residents who are 16 years or over, as of the date of entry, and who have received an invitation to enter the Promotion from the Promoter as a result of purchasing and owning a vehicle from a participating vehicle manufacturer in the time period relevant to the survey.
- 4. Entries must provide contact details on request to be eligible to win. Entrants may only enter in their own name. Inaudible, incomprehensible, illegible, and incomplete entries may be deemed invalid.
- 5. If an entrant is under the age of 18 they must obtain prior consent from their parent or legal guardian to enter the Promotion and the parent or legal guardian may be required to verify the granting of consent and/or sign a release at the discretion of the Promoter. Failure of an entrant's parent or legal guardian to verify consent and/or sign a release under this clause will invalidate all of the entrant's entries.

- 8. Promotion will close by midnight AWST/AWST on the 9th February 2020.
