"Personal information" as used in this policy means information that identifies, relates to, describes, or can reasonably be linked, directly or indirectly, to a specific natural person. It does not include information that is considered anonymous, de-identified, or aggregated by applicable law.

This Privacy Policy describes our practices in connection with information that we collect online:

- Through our Websites.
- In email, text, and other electronic messages between you and the Websites.

It does not apply to information collected by:

- In other contexts, such as through customer engagements; or
- Any third party (including our affiliates and subsidiaries), including through any application or content that may link to or be accessible from or through the Websites.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is to not use the Websites. By accessing or using the Websites, you agree to this privacy policy. This policy may change from time to time (see Changes to Our <u>Privacy Policy</u>). Your continued use of one or more of the Websites after we make changes constitutes acceptance of those changes, so please check the policy periodically for updates.

Children Under the Age of 16

Our Websites are not intended for children, and we do not knowingly collect personal information from visitors under the age of 16. If we learn that we have received personal information from someone under the age of 16, we will delete the information in accordance with applicable law.

Types of Information We Collect

The types of Personal Information we collect about you depend on your interactions with us and are described below.

Information You Provide to Us

We collect Personal Information that you provide to us. For example, we may collect Personal Information when you contact us, request information or other materials, fill out a form, respond to a survey, apply for an open career position, or otherwise communicate with us.

Depending on the context of your interactions with the Websites, the categories of Personal Information that we may collect about you include:

- <u>Unique Identifiers</u> that we can use to identify you as a unique individual, such as your name, telephone number, postal or email address, business phone numbers, business addresses, business email addresses, and a username and password.
- <u>Demographic Information</u>, which may include sensitive Personal Information about protected classifications, such as your gender.
- Professional and Educational Information related to your occupation, such as current and previous employers, your job title, and other information about the organization with which you are affiliated. You might also provide information about your education, degrees, fields of study, languages, professional memberships, qualifications, certifications, and other information commonly found on resumes in connection with job applications.
- <u>Health Information</u> related to your physical abilities to perform prospective job responsibilities in the employment context or requests for accommodations.
- Location Information, such as your city, state, and country.
- Payment Card and Bank Account Information to facilitate payment of invoices.

- <u>Commercial Information</u> pertaining to real estate acquisitions and onsite hunting leases and properties.
- Any other information that you choose to provide.

You can generally visit our Websites without providing us with Personal Information, though we may still collect Personal Information automatically as described in the following section.

For our websites that allow online payment, we use third party processors, currently WorldPay, to assist in securely processing your payment information. We do not store your payment information and do not control and are not responsible for the payment processors or their collection or use of your information. Information We May Collect Automatically

We may automatically collect information from and about you when you interact with the Websites, which may include the following categories of data:

- <u>Device and Connection Information</u>, such as information about your internet connection, device used to access the Websites, your device's operating system, or your browser type.
- <u>Interaction Information</u>. We may automatically collection information about your interactions with the Websites, such as traffic data, content you view, features accessed, pages you view on the Websites, and search terms used.

We and third parties engaged on our behalf may use cookies and similar tracking technologies (collectively "Cookies") to collect information from and store information on your device when you use, access, or otherwise interact with the Websites. Information We Collect from Other Sources

We may collect Personal Information from other sources, such as our business partners. We may obtain Personal Information about you when you provide that information to third party service providers for submission to us, such as through our job application portal. We may also receive information about you when you interact with our social media accounts. We may also collect information from publicly available sources, such as public social media profiles, publications, and other websites or materials available through search engines.

Cookie Policy

We use Cookies to gather information when you interact with our Websites and in email communications. Some tracking technologies help Crest maintain the security and

Google Analytics

Our Websites use Google Analytics to analyze usage patterns of the Websites which tracks such activities through cookies. How We Use the Information We Collect

We may use the information that we collect for various purposes, including:

- To respond to your questions, requests, or communications.

- To expand and maintain our list of contacts.

We further do not share Personal Information that reasonably identifies you with unaffiliated entities for their independent use except when we have your permission, at your direct instruction, as needed to comply with legal obligations, as permitted by law, or as otherwise stated in this Policy.

We may use and disclose anonymous, de-identified, or aggregate information that does not reasonably identify you for any purpose permitted by applicable law.

We may disclose Personal Information that we collect or that you provide:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Crest's or an affiliate's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by Crest or the applicable affiliate about our Website(s) users is among the assets transferred.
- To fulfill the purpose for which you provided it.
- With your consent.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce any agreement, including for billing and collection purposes.

• If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Crest, our affiliates, our customers, or others.
