Title: Continuation of the PCVC contribution Community Safety Fund in 2018 which is managed by the County Durham Community Foundation (CDCF)

Executive Summary: The 2018/19 PCVC Community Safety Fund will be launched on the County Durham Community Foundation website from 7th March 2018 closing on 29th April 2018. CDCF will administer the fund for an extension of two years under the terms of the original contract award. The PCVC, in partnership with CDCF, is making available £150,000 for a fund to support the community and voluntary sector of County Durham and Darlington. The contributions towards the fund are: £100,000 from the PCVC and £50,000 from CDCF. The PCVC is paying CDCF £15,000 to administer the fund. Grants of between £2,000 and £7,500 are available.

The fund will support projects and initiatives across County Durham & Darlington that help keep communities safe and contribute towards inspiring public confidence. The fund is not aimed at organisations that are already funded directly from core commissioned, statutory policing and community safety activities, but will support projects and initiatives that are additional and work at a local community level. Last year the number of evaluation criteria were reduced in order to manage the volumes of potential applications. The three criteria are to:

- Encourage diversionary activities
- Tackle anti-social behaviour
- Tackle harm caused by alcohol, drugs, and violence.

Decision: PCVC continues to contribute £100,000 to the PCVC Community Safety Fund and pays a fund administration fee of £15,000 to CDCF.


