**REQUEST:**

**Title: Continuation of the PCVC contribution to the Young PCVC Community Safety Fund in 2018 which is managed by the County Durham Community Foundation (CDCF)**

**Summary:**

In Autumn 2017, the PCVC agreed to allocate £10,000 to projects sponsored by the Young Police, Crime and Victims' Commissioner (YPCVC). A process to allocate these funds is administered by County Durham Community Foundation (CDCF) at a cost of £2,000. A panel of young people chaired by the Young PCVC met to determine allocation of the fund in October 2017.

The fund has been increased further by a contribution of £10,000 from the High Sherriff 2017-18, Mrs Caroline Peacock, making the total amount available to the Young PCVC £20,000.

**Decision:** PCVC continues to contribute £10,000 to the Young PCVC Community Safety Fund and pays a fund administration fee of £2,000 to CDCF.
