REQUEST:

Title: Provision of £20,000 to County Durham Youth Offending Service to part-fund nurse

Summary: The PCVC has decided to allocate £20,000 to the County Durham Youth Offending Service as part of a co-commissioning solution to meet the health needs of young people presenting to the Youth Offending Service. Young people who offend are usually some of the most vulnerable in society. They often have health issues and yet do not access mainstream health services. There is evidence that shows that improving health can help to reduce reoffending. The sorts of issues which young people who offend often have include poor mental health, sexual health needs, Speech, Language and Communication needs, and substance misuse.

Prior to December 2016, a nursing service was provided to the YOS through a contract between the Durham CCGs and Harrogate Foundation Trust. This means that there is a gap in service as young people's health needs will not be properly assessed and support given. Following the termination of the relevant members of staff, partners have come together to find a solution, including Durham County Council, Durham Public Health, the OPCVC, the Clinical Commissioning Group and NHS England. As part of the solution, the PCVC is contributing £20,000 to fund nursing provision which is being co-funded by Public Health. This funding is for two years and will be reviewed.

Performance will be monitored through the County Durham Youth Offending Service Board.

This decision is taken in line with the PCVC's strategy to invest resources upstream to help prevent problems from escalating and becoming more expensive to solve. If we can reduce offending by young people, this is likely both to improve their life chances and to reduce demand long term on the police and other public services.
