Title: Contribution to the Safe Durham Partnership LGA Peer Review

Executive Summary:

The Safe Durham Partnership is the local Community Safety Partnership (CSP) for County Durham. It oversees the strategic delivery of the 'Altogether Safe' theme as part of the County Durham Partnership.

The Crime and Disorder Act 1998 placed a statutory duty on local authorities to create Partnerships to tackle crime, disorder, anti-social behaviour, substance misuse, other behaviour adversely affecting the local environment and to reduce re-offending. The ODPCVC is represented on the Sade Durham Partnership Board.

Decision:

The decision has been taken under delegated powers to contribute a £1000 to the Safe Durham Partnership LGA peer review.

The Board has proposed, and it has been agreed, that the LGA should be requested to carry out a peer review of the SDP in order to identify any areas of improvement. Partner organisations have been requested to commit £1000 to help to fund it. The total cost is expected to be c. £8500.

Alternatives were considered by the Board. It considered whether a cheaper option, involving self-review, could achieve the same outcome, and it was decided that we did not have the necessary capacity.

It also considered a more expensive option, with a more intensive review. It was agreed that the proposed review would strike the right balance between cost and intensity and therefore provides value for money.

Despite not being a Responsible Authority, and consequently a non-statutory partner, the OPCVC recognises the importance of this work, and will contribute £1000 towards the cost of the review.


