GET LIT IN-SCHOOL PROGRAM: AS PART OF OUR ONGOING WORK TO DISMANTLE SYSTEMIC BARRIERS TO SUCCESS FOR OUR STUDENTS, THIS YEAR WE EXPANDED OUR IN-SCHOOL PROGRAM TO INCLUDE AN ADVANCED, FULL YEAR COURSE FOR GRADES 9-12, UTILIZING OUR "WORDS IGNITE" TEXTBOOK. THE UNIVERSITY OF CALIFORNIA HAS APPROVED THIS COURSE AS AN "A-G" PROVIDER, SATISFYING BOTH THE "G" GENERAL ELECTIVE CREDIT AS WELL AS THE "B" ENGLISH CREDIT. "A-G" COURSES ARE PRE-REQUISITES TO ATTEND CALIFORNIA UNIVERSITIES. THIS IS A MAJOR DEVELOPMENT AS STUDENTS IN UNDER-RESOURCED AREAS ARE OFTEN NOT ABLE TO GET THE CREDITS THEY NEED TO GRADUATE AND ATTEND COLLEGE BECAUSE NOT ENOUGH OF THESE COURSES ARE OFFERED AT THEIR HIGH SCHOOLS.
