Welcome to new members

Update on recent activity

- The litigation task force has met for the first time as a reminder this is a group specifically looking at MBC in the context of litigation practices. For those of you in law firms or legal functions please let me have bug bears from you/your litigation colleagues as examples of behaviours you would like to see addressed by the task force - we will meet monthly so please let us have thoughts in the next couple of weeks.
- We have run various events and conversations to promote MBC including a Make a Difference (Madworld) event, promotion to the International section of the New York State Bar association and an event with the IBA.
- We have run the first **new joiner sessions** (thanks again to Lorraine Roche from Matheson for her help with those). We will run these quarterly, targeted at new joiners to help them think about how to get started, as well as other members who may be feeling stuck and in need of some ideas. The next one will be on 30 June at 2.30pm London time, where I will be joined by Victoria Hills from Freshfields Bruckhaus Deringer. Registration is here. We will take on board the feedback from the first sessions as we plan for that.
- We ran sessions on burnout for member employees in April which were well attended and a recording of one of the sessions is available on the website.
- We have had useful 1:1 meetings with various members to follow up on what they said in their survey responses.
- We continue to run weekly briefing calls for interested organisations. These continue to be well attended. If you are speaking to anyone who might want to know more about MBC please put them in touch with me and we can get them onto one of these calls.

Member survey feedback

I had intended to gently walk through the analysis of the data that we have been able to do to date. Unfortunately, this is where my IT gremlins struck and so I finished the call with a gallop through the slides we had prepared. That gallop didn't do justice to the time and effort members had given to the survey, or that given to analysing and understanding the data. I have therefore recorded an overview of the data which is available here and the slides are attached to this email. Please let me know if you have any questions/observations on this. As stated, the feedback will inform our strategy for the next three years which we will run through at the AGM on 6 July at noon London time.

Signatory updates

We had an update on MBC activity generally at Pantheon from Dianne Remanous and Shaani Desai for which thank you. We also had an insight from Hannah Brophy at Lloyds and Stacey Bairner at Pinsent Masons on a major transaction they have undertaken together and how they applied MBC to it — we often hear how MBC is all very well but can't work in the context of big tickets deals where we just need to get it done, whatever it takes, and so it was inspiring to hear that actually, if the parties put their minds to it, there is no reason why that sort of work cannot be managed in a way that reduces as far as possible the impact on the respective teams involved. I will leave it to you to watch the recording for both of these updates and we are working out how best to take the learning from Hannah and Stacey and create a case study from it.

Law firms and legal teams - bridging the gap between trainee and associate

A couple of people have asked for a session focussed on this career milestone. Law firms and in house teams obviously have extensive programmes of learning and support for trainees but historically that has tended to fall away to a greater or lesser extent upon qualification when the reality is that a newly qualified solicitor is still very much in a learning phase and may require a good degree of ongoing support to continue to grow. I am thinking that it would be helpful to run a workshop on this subject so that members can share ideas and learn from each other – this would not be on the technical side of an NQ's chosen specialism, but more their development as lawyers generally. If you feel you have something to offer ((I can think of a few people who might) it would be great to get together and explore what a session might look like. Please let me know.
