## Contest Terms, Release, and Waiver

Submissions must be received between July 18, 2022, 11:00AM CST, and July 31, 2022, 11:59PM CST.

Public voting will commence August 1, 2022 11:00AM CST and end on August 4, 2022, 11:59PM CST.

The winners of the competition will be declared on August 5, 2022, at 3:00PM CST.
