- Building stamina, resilience, and the ability to audition professionally.
- Maintaining healthy practice.
- Identifying dance concerns or injuries and suggesting suitable exercises and strategies to solve them.
- Providing a safe and nurturing environment where students can learn, make mistakes, and explore to become confident and engaging performers.
- Cool down, summation or learning, setting any homework tasks, preparation, or research.
