

## JUBILEE PARTY CODE OF CONDUCT

.....(county) do hereby subscribed to the Jubilee Party Code of Conduct and  
solemnly declare that;

### PART I

I shall observe this code of conduct pursuant to Articles 91, 92 of the Constitution of the republic of Kenya, Section 8 of the Political Parties Act and the party Constitution, Party Election and Nomination Rules. I declare that I will;

1. At all times abide with this code of conduct so as to promote good governance, preserve and protect the good image of the party;
2. Promote policy alternatives responding to the interests, the concerns and the needs of the party members;
3. Respect, cooperate and uphold the democratic rights of other members in competition for political power so as to implement their policies;
4. Promote sharing and devolution of power and resources.
5. Respect the promotion of consensus building in policy decision making on issues of national importance that affect the party.
6. Respect the right of all persons to participate in the political process including the youth, women, persons with disabilities, minorities and marginalized groups;
7. Respect and promote gender equity and equality, human rights and fundamental freedoms;
8. Be tolerant and inclusive in all my political activities;
9. Respect, uphold and defend the Constitution of the Republic of Kenya;
10. Respect and uphold any other written law relating to elections and political parties;
11. Respect, uphold and defend the party constitution, party election and nomination rules; manifesto and any other party rules and regulations developed and agreed upon in accordance with this code of conduct;
12. Respect, uphold and promote human dignity, equity, social justice, inclusiveness and non-discrimination and protection of the marginalized;
13. Respect, uphold and promote human rights and the rule of law;
14. Promote national patriotism and national unity;
15. Respect, uphold and promote democratic values and principles, performing inclusive the participation of party members and accountable representation in governance for the development of Kenya;
16. Respect, uphold and promote good governance, integrity, respect, tolerance, transparency and accountability;

17. Respect all party organs and the Party leadership;
18. Uphold and promote the principle of regular free, fair and credible elections within the party organs;
19. Respect, uphold and promote the principle of leadership and integrity as enshrined in the constitution of the republic of Kenya;

## **PART II**

### **A) I commit that I shall not;**

1. Engage in or encourage violence by party members or supporters;
2. Engage in or encourage any kind of intimidation of opponents, any other person or any other political party;
3. Engage in influence peddling, bribery or any other form of corruption;
4. Accept or use illicit or illegal money;
5. Accept or use public resources other than those allocated to the political party through the political party fund;
6. Advocate hatred that constitutes ethnic incitement, vilification of others or incitement to cause harm;
7. Obstruct, disrupt, break-up or in any other way whatsoever interfere with a meeting, rally or demonstration of another political party or its leadership;
8. Establish or maintain a Para-military force, militia or similar organization or having any links with such organizations;
9. Use state resources for partisan campaigns;
10. Always use constructive dialogue to manage and mitigate political differences k. Promote national reconciliation and building national unity;
11. Establish or maintain a Para-military force, militia or similar organization or having any links with such organizations;
12. Use state resources for partisan campaigns;
13. Engage in violence, intimidation in language or action that might lead to violence or intimidation;
14. Allow weapons to be carried at political meetings, machettes, voting station
15. Publish or report false, defamatory or inflammatory allegations about political opponents;
16. Prevent eligible voters from having access to political opponents;
17. Bribe eligible voters;
18. Abuse positions of power or privilege;
19. Discriminate on the basis of race, sex, ethnicity, social class or religion;

### **B) I further commit that I will;**

1. Cooperate with other political parties to avoid holding political activities at the same time or place;
2. Take all reasonable steps to protect election officers in their course of duty
3. Take necessary and reasonable steps to instill discipline in Party candidate representatives, employers, supporters.

## **PART III**

I pledge that I shall be loyal to Jubilee Party and that I will;

1. Advocate and defend Party values and aspirations as set out in the Party constitution;
2. Demonstrate positive and dynamic leadership that translate the party policy and programmes into action and impact; and
3. Conduct myself with the highest standard of personal integrity and honour.

### **I further pledge that I will not;**

1. Involve myself in dishonourable conduct.
2. Discriminate on grounds of race, tribe, place of origin, sex or religion.
3. Practice nepotism, tribalism, clanism and favouritism.
4. Incite people against the Party, its members or against other Kenyans.

I am aware that failure to obey this Code of Conduct constitutes a disciplinary offence. This declaration is made to the best of my knowledge, information and belief.
