

ONUU SWEEPSTAKES TERMS & CONDITIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

OPEN TO LEGAL RESIDENTS OF THE UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OLDER EXCEPT: VOID IN NEW YORK, PUERTO RICO, AND ALL OTHER US TERRITORIES AND POSSESSIONS, AND WHERE PROHIBITED BY LAW.

1. **Sponsor:** The sponsor of the 25K Sweepstakes is Candi Holdings, Inc dba Onuu (the "Sponsor")
2. **Eligibility:** To be eligible to enter the 25K Sweepstakes (the "Sweepstakes"), individuals submitting an Entry ("each and Entrant") must sign up at <https://www.onuu.com/>, be 18 years of age as of the date of entry, live in a Qualifying Jurisdiction and NOT have any Disqualifying Condition ("Eligible Entrants"). 3. **Agreement to Rules:** By entering the Sweepstakes, the Entrant ("You") agree to comply with and abide by these Rules and the decisions of the Sponsor, and You represent and warrant that You meet the eligibility requirements. 5. **How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form provided at <https://www.onuu.com/> ("Entry"). The Entry must fulfil all requirements of the Sweepstakes, as specified on the website and in these Rules, to be eligible to win a prize. Entries that are incomplete or do not adhere to the Rules of the Sweepstakes may be disqualified at the sole discretion of the Sponsor. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules of the Sweepstakes, Your submission may be disqualified at the sole discretion of the Sponsor. 6. **Failed Entries:** Sponsor is not responsible for Entries made but not received during the Entry Period for any reason including: lost entries, incomplete entries, or technical failures in the entry process; all such failed Entries are void.
7. **Prizes:** The winner of the Sweepstakes (the "Winner") will receive the following prizes:

8. **Prize Conditions:** The prize is nontransferable. 12. **Privacy:** Information collected is subject to Sponsor's privacy policy.
13. **Terms and Conditions:** The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes should virus, bug, non-authorized human intervention, fraud, or other cause beyond the Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such cases, the Sponsor may select a winner(s) from Entries received before and/or after the action taken by the Sponsor if appropriate. The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Rules. The Sponsor has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Sweepstakes rules; or the use of bots, macros, scripts, or other technical means for entering. 14. **Limitation of Liability and Indemnity:** By entering the Sweepstakes You agree to release and hold harmless Sponsor and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors ("Indemnified Parties) from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, including reasonably attorney fees and costs from: (i) such entrant's participation in the Sweepstakes and/or their acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) unauthorized human intervention in any part of the Sweepstakes; (iii) electronic or human error in the administration of the Sweepstakes or the processing of entries; (iv) technical errors of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (v) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (vi) printing errors; (vii) undelivered, lost, late, stolen, postage due, misdirected or delayed mail; (viii) inaccurate, garbled or incomplete entries whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes; (ix) for any electronic, computer, printing, typographical, or human error (ix) other error relating to or in connection with the

15. **Arbitration of Disputes, Governing Law, NO CLASS ACTION:** Please read this section carefully, You are waiving your right to sue or go to court to assert or defend Your rights connected with participation in the Sweepstakes. This Sweepstakes is governed by the laws of State of Texas, without respect to conflict of law doctrines. By participating in this Sweepstakes, You agree that any and all disputes, controversies, claims, or causes of action arising out of or connected with this Sweepstakes, including the determination of the scope or applicability of this arbitration provision, shall be resolved individually, without resort to any form of class action, exclusively by binding arbitration under the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS. Such arbitration will take place in Travis County, Texas. The arbitrator's decision will be final and binding on the Parties. Further, in any such dispute, under no circumstances shall You be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than actual out-of-pocket expenses (i.e. costs associated with entering the Sweepstakes). You further waive all rights to have damages multiplied or increased.
