Subject: Note from the CEO & MD on the Government of India's initiative to immunize animals against Brucella Disease

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby submit note from the CEO & MD of the Company on the Government of India initiative to immunize animals against Brucella Disease as mentioned below:

As you may be aware, The Government of India, in its first cabinet meeting after the formation of the new government, took a decision (besides taking many others), to focus on animal health. It announced an initiative to control Foot and Mouth Disease (FMD) and Brucella disease in animals.

The government cleared an outlay of INR 13,342 crores (INR 133.42 billion) for this initiative.

As per the Government, "The programme so far has been implemented on cost sharing basis between the central and state governments. In a rare instance of departure, the Central Government has decided to now bear the entire cost of the programme to ensure complete eradication of these diseases and better livelihood opportunities for all the livestock rearing farmers in the country." The end result achievable through this initiative is immunisation of animals against FMD and Brucella disease, improvement in the health of animals, primarily improving milk yields (due to better animal health) and less disease incidences. Farmers in India will also be benefitted economically as well as in terms of their own health.
