In 2014 and 2017, the Federal Court of Australia granted Native Title to the Ngadju people over land surrounding the town of Norseman in Western Australia (**Native Title Determination**).

The Ngadju people are those people who descend from the Apical Ancestors and recognised in the Native Title Determination.

To be successful in your application for membership of the Ngadju Native Title Aboriginal Corporation (**NNTAC**), you are required to satisfy the membership criteria set out below.

NNTAC Board of Directors convene quarterly to review membership applications. The Board will consult with the Elders Advisory Group prior to deciding membership applications. This consultation may include confirming connection to Ngadju country.

If you submitting your application at an NNTAC AGM and introducing yourself to elders and family members, you will meet the membership criteria for 'on country connection' in the Rule Book, Rule 13 (d) and Rule 14. Applications will not be processed at the AGM, applications will be administered in accordance with the NNTAC Membership Application Process Policy.

If you are unable to meet the Membership Criteria your application will be considered unsuccessful and returned as incomplete or requesting further information. Once your membership criteria is considered to meet NNTAC requirements it will be reviewed by the Elders Advisory Group and tabled with the Board of Directors. If your application is unsuccessful after the Elders Advisory Group and Board of Directors have reviewed your application you may object against their decision, Rule 374-380. If you wish to object against your declined application, please contact Memberships at NNTAC for information on the Dispute Resolution Process regarding membership applications.

If your application is successful, the Corporation will confirm your membership in writing within 14 days after approval from the Board of Directors of NNTAC. Following approval by the Board of NNTAC, NNTAC will advise the Charitable Trust of your new membership allowing you to access the funding programs which is managed by the Charitable Trust.

NNTAC Membership gives you the opportunity to attend Corporation meetings and vote on matters concerning Ngadju people and the Native Title Determination area.

APPENDIX A: Information to Membership Criteria

1. Provide Membership Contact Information

Contact information for members is important for the Corporation to have on our register as the Corporation needs to advise members of all meetings being scheduled, send out quarterly NNTAC newsletters, reimbursements of travel when attending meetings. Once a member it is important to keep your contact details up to date, if NNTAC are unable to contact you over a 2 year period, your memberships can be cancelled.

2. Be 18 years of age, show one form of identification

- a. provide a copy of your birth certificate; or
- b. provide a copy of your drivers license; or
- c. provide alternative identification (see membership criteria appendix)

NNTAC understands not every person may have conventional identification and verification methods and with examples identified in the AUSTRAC guidelines and reporting, NNTAC is able to incorporate a flexible approach if 2a and 2b above, of the membership criteria, cannot be met. Membership criteria 2c 'provide alternative identification', can be identification such as:

- an Indigenous community identity card
- a reference from a community Elder
- a reference from a board member of a local Aboriginal Land Council or Aboriginal/ Torres Strait Islander organisation
- a government letter that shows the customer's name and age.

3. Identify to one Family Group

NNTAC understands members can be affiliated to more than one family group and your application will not be refused. However, NNTAC ask for the one family group to be selected to identify members at meetings for voting purposes.

4. Declare you will abide by the Rule Book, Code of Conduct and act in the best interest of the Corporation.

NNTAC Rule Book governs how the Corporation can run and is essential to maintaining good governance. The Rule Book will include relevant parts of the law that affect how a corporation is run:

- the constitution of the corporation
- 'replaceable rules' that have not been changed
- set laws under the Act that the corporation cannot change.

As a member of the NNTAC, you need to declare you will abide by the Membership Rules set out in the Rule Book.

5. Confirm you are a Ngadju person and/or recognized as a Ngadju person

The Native Title Determination is founded from the Ngadju descendants stated in the 2014 and 2017 Federal Court Claim. NNTAC in its role as the Prescribed Body Corporate that holds native title on behalf of Ngadju has a duty to ensure membership



applications provide strong evidence confirming their relationship to the Ngadju apical descendants stated on the claim. Part of the claim is recognizing people adopted by biological descendants in accordance with Ngadju tradition and custom (Rule Book, Schedule 2(2) – Definition of Ngadju people).

6. Detailed information about acknowledging and observing Ngadju Law and Customs e.g. last visit to Norseman or submitting your application at an AGM and introducing yourself to Directors, Elders and family.

The Native Title Determination is recognition of the existence of Ngadju's Native Title Rights on Ngadju Country. Once Native Title is recognised it must be maintained to ensure that these native title rights are protected into the future for the next generation of Ngadju People. Going on and visiting country is one important way of ensuring this connection is maintained. The criteria around going on country is to encourage Ngadju members to visit the Native Title Determination area, reconnect with families and the land.

7. Acknowledges and observes Ngadju law and customs

The Ngadju Native Title Determination is based on the recognition of Native Title rights and interests that derive from Ngadju traditional *laws and customs*. It is important in ensuring that native title is maintained that Ngadju laws and customs continue to be acknowledged and observed.
