# International Business Companies (IBC) Holding, Owning or Dealing with IP Assets

#### **INSTRUCTIONS:**

- 1. With the exception of IBCs responding negatively as per instruction number 2, all fields of this Form, including its relevant annexures are mandatory unless otherwise indicated.
- 2. Where the IBC declares that it **does not** hold, own or deal with any IP asset at section 3.1 of this IPAG Form, it **must not** proceed in completing the relevant annexures as fully described under the instructions below, but must forward this Form to the Commission.
- 3. Where the IBC declares at section 3 of this IPAG Form that it has one or more IP asset, it must supply "Annexure A" for each IP asset reported therein.
- 4. Where the IBC self-created or purchased the IP asset, it must supply "Annexure A (I)", which provides details of each Ultimate Beneficial Owner (UBO) of the IP asset.
- 5. Fill out "Annexure A (II)" to provide details of the IP asset, as well as, details of the jurisdiction of registration of the IP asset.
- 6. Where the IBC declares it has given rights for the use of its IP asset to other entities, it must supply "Annexure A (III)", providing particulars of each entity using the IP asset.
- 7. Where the IBC declares any IP assets it has obtained through assignment, it must supply "Annexure A (IV)", which provides particulars of the licensor for each IP asset.

#### DOCUMENTS TO SUPPORT APPLICATION MUST INCLUDE:

- 1. The IBC Management Structure (i.e. Directors, Shareholders, Ultimate Beneficial Owners, CEO, Complaince Officer, any other Senior Officers).
- 2. Group's Corporate Structure (i.e., the organisational chart, as well as, the management, shareholding and ownership structure of each Company that forms part of the group).

5.	Copy of the Certificate of Registration of each IP asset.
