# Requirements for applicants

02

- 18 years of age or older;
- affidavit of the source of funds;
- Due Diligence approval;
- medical report of good health.

## Who can obtain citizenship alongside the investor:

- ☞ a spouse;
- ☞ children up to 30 years of age who are financially dependent on the main applicant;
- ☞ parents over 55 years of age who are financially dependent on the main applicant;
- ☞ grandparents who are financially dependent on the main applicant;
- ☞ unmarried siblings.

# Documents required

03

- identity documents (passport, birth certificate);
- marriage/divorce certificates, if applicable;
- name change certificate, if applicable;
- proof of address;
- color copies of secondary/higher education diplomas;
- professional reference;
- extract from the Unified State Register of Legal Entities;
- recommendation letter from a business partner/contractor;
- certificate of good conduct/ no criminal record with fingerprints;
- CV or business bio;
- real estate purchase agreement (only for the real estate purchase option);

# Documents required

04

- 3.5 x 4.5 digital photo;
- recommendation letter from School/University Principal for children from 12 to 18 y.o.;
- notarized letter of financial support for family members (ages 18 to 30);
- medical certificate: HIV test (12 years of age and older), blood and urine tests;
- apostille of the entire set of official documents;
- citizenship application.

## ▶ **day 1**

Sign a service agreement, fill out application forms, and pay the initial service and Due Diligence fees.

## ▶ **up to 14 days**

We compile a document package and submit it for Due Diligence performed by Saint Lucia CBI Unit.

## ▶ **3-6 months**

Due Diligence and background check conducted by the state.

## ▶ **up to 1 month**

We submit your citizenship application once we receive the approval, and you make payment of the outstanding investment amount, government fees, stamp duty, and other fees.

▶ up to 14 days

We supervise the issuance of your passport by Saint Lucia and send your Certificate of Citizenship and passport by DHL Express.

## "JEWEL OF THE CARIBBEAN"

Named due to its stunning natural landscapes and crystal-clear waters. Saint Lucia is the only country in the world named after a woman. It was named after Saint Lucy of Syracuse.

While it is the youngest CBI program in the Caribbean, it offers strong visa-free coverage and compelling investment options, including government bonds.

## 1 Can I apply for citizenship on my own?

No, the St. Lucia citizenship program only allows you to apply through an intermediary, a licensed agent. Agents provide advice and support at all stages of the citizenship application process.

## 2 Can I apply for citizenship with my family?

Yes, you can apply for citizenship with your spouse, children, parents, and grandparents, who are your dependents. The number of relatives applying for citizenship together with the principal investor will determine the extra fees and the investment amount.

## 3 What investment options allow me to get my investment back?

When purchasing real estate or government bonds, the investor can recover the investment by selling the assets in 5 years.

**4 Do I have to renounce my previous citizenship to obtain a St. Lucian passport?**

No, dual citizenship is allowed in St. Lucia, so applicants are not required to renounce their current citizenship.

**5 Can I reside in other Caribbean countries with my Saint Lucian citizenship and passport?**

Yes, there is a possibility to live, work, and settle in any other member country of the CARICOM nations.

**6 How long is a St. Lucian passport valid for?**

The first passport is valid for 5 years and is renewable for 10 years.

**7 Do I need to visit the country to apply for citizenship or to renew my passport?**

No, you do not need to visit Saint Lucia. Obtaining citizenship and subsequent passport renewals are done remotely.
