# DOMINICA CITIZENSHIP

# Requirements for applicants

02

- 18 years of age or older;
- no criminal record;
- affidavit of the source of funds;
- Due Diligence approval;
- medical report of good health.

## Who can obtain citizenship alongside the investor:

- ☞ a spouse;
- ☞ children up to 30 years of age who are financially dependent on the main applicant;
- ☞ parents over 55 years of age who are financially dependent on the main applicant;
- ☞ grandparents who are financially dependent on the main applicant;
- ☞ unmarried siblings.

# Documents required

03

- identity documents (passport, birth certificate);
- marriage/divorce certificates, if applicable;
- name change certificate, if applicable;
- proof of address;
- color copies of secondary/higher education diplomas;
- professional reference;
- bank statements for the last 12 months;
- certificate of Incorporation;
- extract from the Unified State Register of Legal Entities;
- recommendation letter from a business partner/contractor;
- certificate of good conduct/ no criminal record with fingerprints;

# Documents required

04

- CV or business bio;
- real estate purchase agreement (only for the real estate purchase option);
- 3.5 x 4.5 digital photo;
- recommendation letter from School/University Principal for children from 12 to 18 y.o.;
- notarized letter of financial support for family members (ages 18 to 30);
- medical certificate: HIV test (12 years of age and older), blood and urine tests;
- apostille of the entire set of official documents;
- citizenship application.

## ▶ **day 1**

Sign a service agreement, fill out application forms, and pay the initial service and Due Diligence fees.

## ▶ **up to 14 days**

We compile a document package and submit it for Due Diligence performed by Dominica CBI Unit.

## ▶ **3-6 months**

Due Diligence and background check conducted by the state.

## ▶ **up to 1 month**

We submit your citizenship application once we receive the approval, and you make payment of the outstanding investment amount, government fees, stamp duty, and other fees.

▶ up to 14 days

We supervise the issuance of your passport by Dominica and send your Certificate of Citizenship and passport by DHL Express.

## "THE CARIBBEAN'S BEST KEPT SECRET"

One of the most unique aspects of Dominica is its geography, which is characterized by mountainous terrain, volcanoes, and hot springs.

An attractive option for those who wish to gain citizenship in a beautiful Caribbean nation with strong visa-free mobility, including China, a stable and peaceful political environment, and a strong economy.

## 1 Can I apply for citizenship with my family?

Yes, you can apply for citizenship with your spouse, children, parents, and grandparents, who are your dependents. The number of relatives applying for citizenship together with the principal investor will determine the extra fees and the investment amount under the Economic Diversification Fund option.

## 2 Do I have to visit Dominica to obtain citizenship?

No, the applicant does not have to go to the country when they apply for the passport or after they get it.

## 3 How long is the Dominica passport valid for?

The Dominica passport is valid for 10 years; it is renewable.



## 4 Besides the contribution amount, what else is included in the costs of obtaining citizenship?

The investor pays government fees, including for Due Diligence, professional services, and passport delivery costs.

## 5 Can I change my first and last name when applying for Dominica citizenship?

It is possible to change your name after obtaining Dominica passport. Under the terms of the program, the client does not need to be present to apply for a name change.
